Sir,
In producing herewith the following seized articles as per seizure list, I, SI Debashis Dutta of Anandapur PS lodged complaint against accused person namely Gour Das(45 yrs), S/O-Lt Ponchu Das of vill-Natunbazar, PS-Anandapur, Dist-Paschim Medinipur to the effect that today (14.11.2021) at 20.35 hrs during my patrolling duty at PS area vide GDE No.-548 dt: 14.11.2021 along with LC/2645 Kuheli Saha, NVF- 688 Biswajit Pramanik and HG- 099 Pabrita Mondal, all of Anandapur PS received an information from secrete source that one Gour Das(45 yrs), S/O-Lt Ponchu Das of vill-Natunbazar, PS-Anandapur, Dist-Paschim Medinipur storage huge quantity of illicit liquor in his own house at Natunbazar under Anandapur PS and stock piling huge quantity of ID liquor for the purpose of sell. Accordingly as per direction of my superior myself along with force had been to Natunbazar.

At 21.05 hrs I reached at the house of one Gour Das(45 yrs), S/O-Lt Ponchu Das of vill-Natunbazar, PS-Anandapur, Dist-Paschim Medinipur and seeing the Police party, above noted charged person tried to take to his heel. But, before he could make his safe escape we chased him and caught him up. Being asked he disclosed his above identity and confessed that he is residing of that house. We searched his house and found huge quantity of liquor locally known as "Chullu" has been stocked there and local information reveals that aforesaid Gour Das(45 yrs), S/O-Lt Ponchu Das of vill-Natunbazar, PS-Anandapur, Dist-Paschim Medinipur is running this business illegally without any valid license. Hence I seized the following articles under the offence of Bengal Excise Act in presence of witnesses and the articles were labeled too by taking the signature of witnesses and arrested the charged persons namely Gour Das(45 yrs), S/O-Lt Ponchu Das of vill-Natunbazar, PS-Anandapur, Dist-Paschim Medinipur maintaining all formalities of arrest rule. The descriptions of the seized articles as follows -

- 1) 02 (Two) Plastic Jarkin containing 05 litres each ID liquor which is locally known as "Chullu".

One bottle from each plastic Jarkin the above noted items kept as sample
All the above noted seized articles valued approx more than Rs. 500/-

Therefore, I pray a specific Case against the arrested person Gour Das(45 yrs), S/O-Lt Ponchu Das of vill-Natunbazar, PS-Anandapur, Dist-Paschim Medinipur may kindly be started under Bengal Excise Act and arranged for its investigation.
