Sir,

In producing herewith the following seized articles as per seizure list, I, ASI-Nemai Saha of Anandapur PS lodged complaint against Tapas Senapati (34 Yrs) S/O-Lt Goutam Senapati of Vill-Uttar Piyasala PO-Amdangra, PS-Anandapur, Dist-Paschim Medinipur to the effect that today (26.11.21) at 07:15 hrs during my patrolling duty at PS area vide GDE No-1054 dt: 26.11.21 along with C/-854 Tamal Taru Banerjee NVF-18132416 Samir Dandapat, NVF-18132425 Indrajit Das, all of Anandapur PS received a information from secrete source that one Tapas Senapati (34 Yrs) S/O-Lt Goutam Senapati of Vill-Uttar Piyasala PO-Amdangra, PS-Anandapur, Dist-Paschim Medinipur storage huge quantity of illicit liquor in the own shop at Uttar Piyasala under Anandapur PS and stock piling huge quantity of ID liquor with for the purpose of sell. Accordingly I had been to Uttar Piyasala as per direction of my superior.

At 20:05 hrs I reached at the own shop of one Tapas Senapati (34 Yrs) S/O-Lt Goutam Senapati of Vill-Uttar Piyasala PO-Amdangra, PS-Anandapur, Dist-Paschim Medinipur and seeing the Police party, above noted charged person tried to take to his heel. But, before he could make his safe escape we chased him and caught him up. Being asked he disclosed his above identity and confessed that he is owner of those shops. We searched said shop and found huge quantity of liquor has been stocked there and local information reveals that aforesaid Tapas Senapati (34 Yrs) S/O-Lt Goutam Senapati of Vill-Uttar Piyasala PO-Amdangra, PS-Anandapur, Dist-Paschim Medinipur I asked him to produce any valid documents in respect of said business but he fail to produce the same. Hence I seized the following articles under the offence of Bengal Excise Act in presence of witnesses and the articles were labeled too by taking the signature of witnesses and arrested the charged persons namely Tapas Senapati (34 Yrs) S/O-Lt Goutam Senapati of Vill-Uttar Piyasala PO-Amdangra, PS-Anandapur, Dist-Paschim Medinipur maintaining all formalities of arrest rule. The descriptions of the articles as follows -

1) Approx 20 liters ID locally known as Chullu.

One bottle from the above noted item kept as sample  
the above noted seized article

Therefore, I pray a specific Case against the arrested accused person Tapas Senapati (34 Yrs) S/O-Lt Goutam Senapati of Vill-Uttar Piyasala PO-Amdangra, PS-Anandapur, Dist-Paschim Medinipur may kindly be started under Bengal Excise Act and arranged for its investigation.
