Sir,

In producing herewith the arrested charged person namely Bhagirath Khamrui S/O- Jiten Khamrui of Korangapota, PS-Anandapur Dist-Paschim Medinipur along with seized articles as per seizure list, I, ASI Asis Banerjee of Anandapur PS lodged this complaint against the aforesaid person as suo-moto to the effect that today (01.02.2022) at 18:55 hrs during my evening patrolling duty vide C C No. 444/22 dt: 01.02.2022 & GDE No. 41 dt: 01.02.2022 alongwith NVF 1167 Bhim Soren, NVF 185 Goutam Duley, all of Anandapur PS, received one telephonic information from one of my reliable source that Bhagirath Khamrui S/O- Jiten Khamrui of Korangapota, PS-Anandapur Dist-Paschim Medinipur storage huge quantity of illicit liquor in his own shop for the purpose of sell. Accordingly I informed the matter to the superiors and as per their direction had been to Hijli village.

At 19:25 hrs myself with my accompanied forces reached at the shop of said Bhagirath Khamrui and seeing the Police party, above noted charged person tried to take to his heel. But, before he could make his safe escape we chased him and caught him up. Being asked he disclosed his above identity and confessed that he is the owner of the shop. On demand he could not produce any valid documents in favour of his illegal business. We searched the shop Bhagirath Khamrui and seized the following articles in presence of local witnesses and the articles were labeled too by taking the signature of witnesses and the charged person alike. Then I arrested him after observing all formalities as guided by the Apex Court.

The descriptions of the articles as follows -

- 1) 01 (One) White Colour Jaricane which contain 10 Ltrs. (Approx) I.D Liquor locally called as "Chullu".
- 2) 4 (Four) bottles Country Sprit name as Dilruba containing 600 m.l each.

Therefore, I pray a specific Case against the above noted charged person u/s 46 A Bengal Excise Act may kindly be started and arrange for its investigation.
