Sir,

In producing herewith the arrested charged person namely Goutam Khamrai @ Madan Mohan Khamrai (34 y) S/O- Kalipada Khamrai of vill- Akulsara, PO-Garhsenapota, PS- Anandapur, Dist- Paschim Medinipur along with seized articles as per seizure list. On 17.10.2022 at 17.25 hrs, during my Mobile Patrolling duty Vide Anandapur PS GDE No-700 Dt-17.10.2022 huge quantity of illegal fire crackers have got accumulated for the purpose of selling in the house of Goutam Khamrai @ Madan Mohan Khamrai. Then I informed my superior and as per their direction myself along with detailed force C/-2986 Bijay Ghorai, NVF-1271 Manik Giri, NVF-1897 Banuram Mandi proceed towards Akulsara village to working out the information by PS Govt. Vehicle. At 18.15 hrs myself along with force reached at Akulsara Village and consulted with the accompanied forces and also gave necessary instruction to them. I contacted with some local people and discussed the purpose of our visit at that place at that time and requested them to accompany us in that raid, but they did not agree to accompany us.


We had been to the house compound of Goutam Khamrai @ Madan Mohan Khamrai S/O- Kalipada Khamrai of vill- Akulsara, PO-Garhsenapota, PS- Anandapur, Dist- Paschim Medinipur, for raid and search and we found that Goutam Khamrai @ Madan Mohan Khamrai S/O- Kalipada Khamrai of vill- Akulsara dumped the following articles in his house for Selling and dispatched to the respective sellers. It also noticed that preparing and packing of such articles in sacks. Then I apprehended owner of the house namely Goutam Khamrai @ Madan Mohan Khamrai and asked him to show valid license regarding the following articles which are dumped in his house for the purpose of selling. But he could not show any valid license regarding the following articles. After that I seized the following articles under proper seizure list duly signed by the accused person and the Police witnesses, also packed all seized articles. Then I arrested the person namely Goutam Khamrai @ Madan Mohan Khamrai S/O- Kalipada Khamrai of vill- Akulsara, PO-Garhsenapota, PS- Anandapur, Dist- Paschim Medinipur after maintaining all formalities of LD APEX Court of India and NHRC. It is strongly established that the said accused person namely Goutam Khamrai @ Madan Mohan Khamrai committed an offence for causing negligent conduct in respect to fireworks illegally at his house premises without any valid documents or license which endanger human life or property.

Hence, I lodged complaint against arrested accused person namely Goutam Khamrai @ Madan Mohan Khamrai S/O- Kalipada Khamrai of vill- Akulsara, Mouja- Gotaugrasanja, PS- Anandapur, Dist- Paschim Medinipur under proper section of law.
